**BRIEF BACKGROUND**

**SPINderella:**

The SPINderella is an all female national spinning competition which will be hosted at Wheelz n Smoke Arena on the 11th August 2018.

Spinderella is a programme aimed at empowering women in motorsport, particularly in Spinning. The name “SPINDERELLA” represents a woman whose attributes were unrecognised in the space of motorsport, one who unexpectedly achieves recognition after a period of neglect , Wheelz n Smoke is giving a platform to women, and take part in this growing extreme sport.

**EVENT OVERVIEW: “SPINderella”**

- All spinners are expected to arrive at the venue “Wheelz ‘n Smokes Arena” earlier from 11:00am to register and sign up either for their social licenses or on-day special spinning licenses.
- The event and choreographed/competitive spinning will commence at 12h00 – 18h00 and will be intercut with other mural activities, dancing and artists’ performances, etc...
- Undisturbed freestyle spinning will commence at 19h00 – 22h00 and will be intercut with traditional activities like dancing, artists’ performances, etc...

## SPINNERS RESPONSIBILITIES AND LEGIBILITY

All spinners will have to book and sign up for Social/Special Spinning Licenses in order to be legible to spin... **(MSA to advise in consultation with the promoter about the Social Licenses)**

All participating spinners will abide and comply with Supplementary Regulations as drafted herein.

**SPINderella** will competitive spinning around a pre designed course therefore there will be judges, and a strict approach will be used in dealing with activities around the spinning pitch and surrounding areas. Wheelz n Smoke will administer a program and a spinners' register for all spinners.

Spinners that do not comply or have spinning licenses will not be allowed to participate in this event. MSA Steward, Club Steward and Clerk of the Course will ensure that all spinners entering to spin comply with all the rules as set out for the particular event.

## **PRE START REQUIREMENTS**

### ***A Spinner may not start spinning until:***

- He/she has completed all documentations provided to him/her by the Clerk of the Course, Club Steward and MSA Steward.
- His/her spinning car complies with the rules set by the Clerk of the Course, Club Steward or MSA Steward and Chief Inspector.

## **PENALTIES**

### ***A Spinner may be penalized if he/she is found to have:***

- Falling to report to the start line on time as required of him/her
- Falling to report at the briefing
- Falling to sign the attendance register
- Leaving his/her car unattended in the spinning pit with no valid reason
- Depositing foreign matters including debris, oil prohibited chemicals in the spinning pit
- Un-sportsman behave
- Driving dangerously
- Spinning without a license or signing the special/indemnity form
- Disregarding a specific instructions from an official

## **GENERAL RULES FOR THE EVENT**

- Spinners can share a spinning car during this event
- Petrol and Tyres to be provided by the Promoter
- Any car can spin at this event (front/rear wheel)
- Only two cars can be allowed to spin at the same time provided they, the spinners agree to the challenge and if the space is sufficient in the pit.
- Any spinner can perform a "get out stunt", but they are advised to have a co-driver.

## **PASSENGERS/STUNT DRIVERS**

*A passenger/stuntman may be carried in a spinning car subject to the following conditions:*

The passenger/stuntman must sign an indemnity form before getting inside the car

A passenger/spectator signing up for a "Joy Ride" must put on a SAFETY BELT at all times

It's the responsibility of the Spinner, the Passenger and Stuntman to provide themselves with necessary protective gear

***NB: The promoters of the event reserves the Right to cancel/postpone the event in consultation with the MSA Steward.***
