#### **13.9. PRIZE-GIVING:**

Prize giving will take place once the results are final. Competitors who do not attend the prize giving to receive their prizes / awards will forfeit them unless they have received permission from the COC.

#### 13.10. DSP'S AND REFUELLING:

Main DSP will be at the Race Headquarters and there will be no outside refuel points

#### 13.11. GPS DEVICES:

It is compulsory for all National competitors to race with a functional GPS device

#### **13.12. ROUTE/EVENT DISCRIPTION:**

The route will be an Enduro with a 15-minute decontrol after the 4<sup>th</sup> Lap-50% of the distance. The top 10 riders of each class are to hand in their GPS's for Scrutiny after the event.

#### **13.13. FINISH AND ROUTE CHECK CONTROL CARDS:**

Helmet stickers will be supplied and must be on the left hand side of the helmet. The onus rest with the competitor to hand in his sticker on completion of the event. THIS STICKER IS TO BE PLACED ON THE REVERSE SIDE OF THE EVALUATION FORM / INCIDENT REPORT FORM.

#### **13.14. SWEEPS AND RECOVERY:**

It is intended that there will be sweep vehicles on all racing sections to pick up competitors who are injured or stranded. Competitors are to note that the organisers are not obliged to provide any service for the recovery of motorcycles / quads but will endeavour as far as possible to assist where ever possible

#### 13.15. RESULTS:

The provisional results will become final 30 minutes after they have been published. GCR200.vii

Should there be an unreasonable delay in announcing the results; the Stewards of the Meeting may postpone such announcement. GCR141.h

#### **13.16. TROPHIES / AWARDS:**

Awards will be made to the riders placed first to third in their respective classes, including all special awards as per Art 6 of the 2018 MSA SA National Enduro SSR's.

Note: All awards will be distributed at prize giving. Any competitor who is not present and who has not made prior arrangements with the Clerk of the Course or Secretary of the Meeting shall forfeit all such awards – Refer GCR 280 (iii).

#### **13.17. RETIREMENT AND EVALUATION REPORT FORMS:**

R250.00 fine for failure to hand in an Event Evaluation Form as soon as finishing the race, but latest within 1 hour of respective time bars or as soon as arriving back at racing control. If unable to do so, due to being stuck / injured on the route, competitors should phone the COC in the interim.

#### **13.18. REFRESHMENTS:**

There will be food and beverages for sale.

#### 14. POSTPONEMENT, ABANDONMENT OR CANCELLATION:

The Organisers reserve the right to postpone, abandon or cancel the meeting or any part thereof. In the event of any of the above, the Competitor/Entrant has no right to claim against the Promoter/Organiser in respect of any loss or damage he/she may incur, other than that specified in GCR 244. The meeting will not be postponed, abandoned or cancelled without the consent of the MSA Steward in accordance with GCR 152.

#### **15. ADVERTISING:**

It is condition of entry that in addition to the advertising referred to in GCR 246, competing motorcycles shall also display the advertising, if any, as stipulated in the Championship and specifications for the class for which the motorcycle is entered.

#### 16. POINTS:

Points will be scored as per Art 7 in the 2018 MSA SA National Enduro SSR's.



#### **17. PROTESTS:**

All protests and appeals will be dealt with as set out in GCR Appendix R, Parts IX and X.

#### **18. TRANSPONDERS:**

Transponders (Race control tags) are compulsory and will be available for purchase at documentation. Riders remain responsible for ensuring the number scanned on their race control tags are identical to their race number and the number they entered with. Should this be incorrect, time keepers and organizers will NOT be held accountable for the riders times not appearing on the results.

#### **19. RIGHTS OF THE CLERK OF COURSE:**

The Clerk of the Course and/or the Stewards of the Meeting have the right to call a halt to an event due to "force majeure" for any of the following, but not limited to, reasons:

- i) Extreme weather conditions
- ii) Serious or fatal accident
- iii) Sections of the route being deemed impassable owing to recent extreme weather or other unforeseen circumstances.
- iv) Dangerous circumstances for riders involving spectators or bystanders.
- v) Any other circumstances which the Clerk of the Course, in his sole discretion, deems to be dangerous or prejudicial to competitors.
- vi) In the event of an event being halted as above or for any other reason, the Clerk of the Course will inform all marshal points to stop competitors. The riders will be scored back to the last timing point they passed before the event was stopped.

#### 20. CROSSING OF PUBLIC / DISTRICT ROADS:

As the organizer we have fully acquainted ourselves with Art 20 of the 2018 MSA SA National Enduro SSR.s

We the organizers are also aware and have acquainted ourselves with the provisions of Section 317 of the Road Traffic Act and confirm that the event officials have been made aware of the above section. By allowing the event to proceed we accept that all requirements are complied with and where applicable all relevant permissions are in place.
