The Jaguar Trial is a Closed Club Event open to Drivers and Navigators who are members of SARRA. The results of the event will count towards the 2018 SARRA NORTHERN REGIONS RALLY SERIES and the 2018 SARRA BLIND NAVIGATORS GAUTENG **RALLY SERIES**

#### 8. Description of the event

The event will consist of an open odo regularity rally for motor vehicles and an open odo regularity rally for motor vehicles with sight impaired navigators. Each rally will cover a common route of approximately 200 km in length over one day and will be scored separately. The event will be all tarmac with no special stages. There will be only one speed group where the set speeds will not exceed 10 km/h below the set speed limit. All controls per the SARRA SSRs for 2018 may operate

#### 9. **Entries**

- Entries open immediately and must reach the organisers by 12 noon on Friday 15th June 2018, which will be the closing 9.1 date for entries
- 9.2 Entry Fees: Normal: R 350,00 per crew

BNRC: R 200,00 per crew

PLEASE NOTE that these entry fees INCLUDE the rental of a data logger (see 18.3 below), and any competitor using his/her own logger will receive a discount of R100 on the entry fee

9.3 Entry fees are payable at Documentation in cash

Entry fees are payable by all competitors who submit an Entry Form, even if they do not attend the event

Late entries and telephonic entries may be accepted subject to a late levy of R 100,00 and will start at the back of the field and will not appear on the published entry list

- 9.4 The maximum number of entries is 60
- 9.5 The organisers reserve the right to cancel the event should there be less than 30 entries
- 9.6 Use of Public Roads:

We the organisers are aware and have acquainted ourselves with the provisions of the Road Traffic Act and confirm that the event officials have been made aware of the provisions. By allowing the event to proceed we accept that all requirements are complied with and where applicable all relevant permissions are in place

#### 10. Documentation and Scrutineering

- 10.1 Documentation and scrutineering will take place at the start venue from 07h00 to 08h30 on 24th June 2018
- 10.2 Provincial Driver's Licences and SARRA Membership will be checked at documentation. Any crew not having the correct documentation will not be allowed to start

### 11. Scrutineering (Refer to GCR 254)

The following particulars may be checked:

- Warning Triangle
- Indicators / Hooter / Windscreen wipers / Battery clamp / Tail lights / Stop lights / Head lights
- Mounted Fire Extinguisher. The fire extinguisher shall be in good working order, and, if a gauge is not fitted, evidence must be furnished to prove that the extinguisher was purchased new or serviced within the six months prior (GCR 257 refers)
- Advertising decals as supplied by the organiser
- Driver's Licence
- Valid vehicle licence
- Safety Belts: In the event of passengers in the car, a minimum of a 3-point safety belt, where appropriate, must be fitted for each passenger
- Medical aid kit recommended for all competitors but not obligatory

Please note that each competitor will be required to sign an acknowledgement that his/her vehicle is in a roadworthy condition and in their opinion is fit to compete on this event

#### 12. Results

- 12.1 Provisional Results will be announced at the finish venue as soon as possible after the last car finishes or not later than 16h00
- 12.2 Should Provisional Results not be available at this time; an announcement will be made as to when they will be available
- Subject to protests, the Provisional Results will become final half an hour after the announcement of the Provisional Results. Refer to GCR 200 (viii)

## 13. Classes

SARRA NORTHERN REGIONS SERIES CLASSES:

Class A Open to all entrants where either the driver or navigator have been seeded by SARRA as "Class A" for the 2018 calendar vear

Class B Open to all entrants where either the driver or navigator have been seeded by SARRA as "Class B" for the 2018 calendar year and neither driver nor navigator falls into Class A above

Class C Open to all entrants not falling into Classes A or B above

Class D Open to all new entrants who have not competed in more than two SARRA events in any previous calendar year AND do not appear on the SARRA Class List in Classes A, B or C.

### 14. Prizes and Awards

The prize giving will take place at the finish venue immediately after the results become final

The following prizes will be awarded, providing sufficient entries are received:

### 18. General Information

17.

- 18.1 The prize giving function will be open to all involved in the rally as well as their guests. It is compulsory for all competitors to attend the prize giving GCR 280 iii) refers
- 18.2 Lunch will be available for purchase by competitors and their guests. A cash bar will operate
- The event will be timed by means of GPS data loggers. Entrants who have their own loggers may use them on the event provided they are compatible with the scoring system utilized by the organizers of the event. It is the obligation of such competitors to ensure that their loggers are properly charged, are cleared of prior information, are functioning correctly and reading at appropriate intervals. The organisers assume no responsibility in respect of such loggers. In the event that a competitor uses his/her own logger, they will receive a discount of R100 on the entry fee for the event. The organisers will ensure that rented loggers are fully charged and are operating correctly at the start of the event. Competitors who rent loggers will be required to sign a loan document in terms of which they will be held responsible for the cost of the logger should they lose or break them during the course of the event
- SARRA Membership will be available for purchase at documentation. Normal annual membership is R 250 or R 150 for members of bona fide car clubs and R50 for a one event membership. Annual membership for BNRC competitors is R 50
- 18.5 The Association undertakes to display the MSA Flag at the start of the event
